#### **FORWARD STATEMENT**

### **EXECUTIVE SUMMARY**

His is Mohamed Sheshu Sheriff, Executive Secretary of the APRM National Secretariat in Sierra Leone, appointed into office by President Bio on September 8, 2023, and formally assumed office on October 2, 2023. Since then, he has demonstrated leadership and commitment to the APRM process and its objectives. In the first 100 days of his tenure as Executive Secretary of the African Peer Review Mechanism (APRM) National Secretariat, Mr. Sheriff showed remarkable leadership, intense devotion to duty, and a strong sense of commitment and excellence to the furtherance of His Excellency President Julius Maada Bio's June 2023 manifesto commitments including promotion and consolidation of democratic good governance in Sierra Leone.

Upon assuming duty, Mr. Sheriff first laid out a clear action points to his national assignment as the new head of the APRM National secretariat, including 30-Day Plan (Learn operations, review report, engage stakeholders. Plan work, train staff, partner, propose projects); 60-Day Plan (Raise awareness, track projects, support policy, collaborate regionally, mobilize resources); 100-Day Plan (Tackle governance issues, consult stakeholders, empower citizens, improve staff, report progress). Upon assuming into office, his first national assignment was the launching of the APRM Targeted Review on "Unconstitutional Change of Government" (UCG) in Sierra Leone, which President Julius Maada Bio had initiated in 2022, and engaged in nationwide popularization efforts about the role of the APRM and the UCG.

He also prioritized media interactions, built the capacity of his staff, represented Sierra Leone at the APRM's 20th-anniversary event in South Africa, where he chaired the APRM National Secretariat Working Group, and fostered collaborations with key partners such as the APRM continental secretariat, the Center for Global Africa, and other development partners in Sierra Leone. His emphasis on unity and inclusivity among the APRM staff and his rekindling of communication between the APRM Sierra Leone and the APRM continental were significant achievements during his 100 days in office. He also conducted public lectures at the Njala University and the Eastern Technical University, highlighting the APRM's role in promoting democratic governance and inclusive development in Africa.

He faced some challenges of mobility, visibility, and office space, which he sought to overcome by partnering and collaborating with democracy and pro-democracy activists, development partners, and diplomatic missions. Alongside the APRM Focal Point and Minister of Public Administration and Political Affairs, Mr. Sheriff showcased Sierra Leone's strategic vision and achievements in the APRM process at the 33rd Ordinary Session of the African Peer Review Forum in Freetown, Sierra Leone, in February 2024, where President Julius Maada Bio and Dr. Abdoulie Janneh signed a Memorandum of Understanding on the Second Generation Country Review in Sierra Leone. He also supported Vice President Dr. Mohamed Juldeh Jalloh and the APRM Focal Point, Minister Amara Kallon in delivering two pivotal reports at the African Union's 37th Assembly of Heads of State and Government, high-lighting Sierra Leone's commitment to regional advancement and integration as well as global reform.



The APRM Sierra Leone Office serves as the country's focal point for the APRM, a voluntary self-assessment tool established by the African Union. Since Sierra Leone's accession to the APRM in 2004, its main goal is to promote good governance, transparency, and accountability, with the aim of fostering socio-economic development and improving the well-being of Sierra Leone's citizens. This is achieved by conducting a comprehensive country review, targeted reviews, and self-assessments engaging stakeholders, including the civil society, and the private sector etc. and assessing governance practices in various thematic areas. The office also collaborates with the APRM Continental Secretariat and other country offices to share experiences and enhance regional cooperation. Upon assuming into office, as the Executive Secretary of the APRM National Secretariat in Sierra Leone, I envision a country that upholds the highest standards of good governance, transparency, and accountability, and that leverages its rich human and natural resources to achieve inclusive and sustainable development for all its citizens. To realize this vision, I will dedicate my first 100 days in office to the following mission: Familiarize with operations, review Country Review Report, and engage stakeholders. Develop work plan, train staff, establish partnerships, and propose projects; Launch awareness campaign, monitor projects, support policy formulation, regional collaboration, and explore resource mobilization; and address governance gaps, consult stakeholders, strengthen citizen participation, and enhance staff capacity, report progress. These plans aim to ensure a comprehensive understanding of operations, foster collaboration with stakeholders, enhance staff capabilities, and implement initiatives aligned with the APRM's objectives. Additionally, we will prioritize public awareness, monitoring and evaluation, policy support, and resource mobilization for effective governance assessment and development in Sierra Leone. To report on the achievements and challenges of my first 100 days in office, highlight the successes and opportunities, and identify the areas for improvement and action. Through these activities, I aim to ensure a comprehensive and effective implementation of the APRM process in Sierra Leone, and to contribute to the promotion of good governance, transparency, and accountability, with the ultimate goal of fostering socio-economic development and improving the well-being of Sierra Leone's citizens.

#### THE LAUNCH OF THE UCG REPORT IN SIERRA LEONE

A major milestone that Sheriff achieved in his first 100 days in office was the coordination of the launching of the APRM Targeted Review on Unconstitutional Change of Government in Sierra Leone, which President Bio commissioned to evaluate and address the issue of unconstitutional government changes in Africa. This was a landmark initiative that demonstrated Sierra Leone's leadership and commitment to democratic governance and the rule of law. Sheriff coordinated the launch of the report at the Bintumani Conference Centre in Freetown on November 1, 2023, with the Chief Minister, Dr. David Moinina Sengeh, representing the President, and the APRM Lead Panel Member for Sierra Leone, Ambassador Princess Inonge Mbikusita-Lewanika, in attendance. The launch was followed by a nationwide awareness campaign with district and local councils, resident ministers' offices, provincial secretaries, and district officers, conducting impactful radio and television engagements across various communities in the South, East, North, and North West. These regional engagements ensured that the report reached a wide and diverse audience and stimulated dialogue and action on the issue of unconstitutional government changes in Sierra Leone and Africa.

#### **MEDIA ENGAGEMENTS**

In his first days in office, Mr. Sheriff also prioritized media outreach, recognizing the importance of communicating the APRM's message and activities to the public. He conducted four interactive sessions with over 20 media houses, spanning both print and electronic media including Radio Democracy, Star Line Radio and Television etc. He also engaged with 15 social media influencers including the Sierraloaded, Sarah Kallay Media, Samantha, SL News Blog etc., amplifying the APRM's message. He used these platforms to inform, educate, and sensitize the public about the role and relevance of the APRM in promoting good governance, democracy, peace, and development in Africa. He further highlighted the achievements and best practices of Sierra Leone in the APRM process, such as the political commitment, the partnership and collaboration with the media, and the implementation of the UCG

targeted review recommendations.



#### CAPACITY BUILDING AND UNITY AMONG THE APRM STAFF IN SIERRA LEONE

One of the first actions that Mr. Sheriff took as the Executive Secretary of the APRM National Secretariat in Sierra Leone was to enhance the organizational capacity and unity of his staff. He ensured that every staff member, from top-tier to janitorial staff, had access to a computer and Mifi internet with a three-month subscription. He provided training and mentoring to the staff on various aspects of the APRM process and its thematic areas. He also fostered a culture of coordination, inclusion, and knowledge sharing in decision-making among the staff. He unified the APRM staff in Sierra Leone and created a conducive and productive work environment, including leading by example and inspired his staff to work with passion, dedication, and professionalism.



#### STRENGTHENING PARTNERSHIP AND COMMITMENT TO REGIONAL COLLABORATION

Mr. Sheriff showed initiative, innovation, and leadership in his first 60 days in office as the Executive Secretary of the APRM National Secretariat in Sierra Leone. He started a conversation and kept regular and constructive communication and cooperation with the APRM continental secretariat, the technical and administrative arm of the APRM. He made sure that the APRM national secretariat in Sierra Leone followed the APRM standards and principles and got the necessary support and guidance from the APRM continental secretariat. He also established a partnership with the Center for Global Africa, a research and policy think tank based in the United States. He has initiated a partnership with the Center for Global Africa on various projects and initiatives related to the APRM process and its thematic areas, such as the APRM Governance Index, the APRM Youth Symposium, and the APRM Diaspora Engagement. He further strengthened Sierra Leone's ties within the African Union and the international community, highlighting the country's commitment to regional advancement and global reform.

Mr. Sheriff also represented Sierra Leone at the APRM's 20th anniversary in South Africa

from December 8 to 15, 2023, alongside the APRM Focal point. During the anniversary, Sheriff showcased Sierra Leone's achievements and best practices in the APRM process, such as the political commitment, the partnership and collaboration with the media, and the implementation of the UCG targeted review recommendations. He also highlighted the strategic vision and direction of Sierra Leone in the APRM process, such as the launch of the Second Generation Country Review and the promotion of democratic governance and inclusive development. As Chairperson of the APRM Forum of National Secretariat Chairs, he chaired the APRM National Secretariat Working Group and participated in the peace and security working group, collaborating effectively with APRM Focal Point Amara Kallon, as well as jointly coordinated the attendance of President Julius Maada Bio's at the APRM 20th anniversary.

The Forum discussed and approved several targeted review reports of certain African countries including the Republic of Uganda's Targeted Review on the "Underdevelopment of Infrastructure, Agriculture and Non-Responsive Civil Service, the Republic of Mozambigue's Targeted review of Mozambique on "State Resilience, Food security and Natural Disasters Zambia", During the meeting, President Bio welcomed the Central African Republic as a new member, and confirmed the new APRM Troika. In addition, both President Julius Maada Bio, and Dr. Abdoulie Janneh signed the Memorandum of Understanding on the Second Generation Country Review in Sierra Leone, officially launching its self-assessment process. The review will cover five thematic areas, encompassing all sectors of national development, with completion expected by the end of 2025. The event highlights President Bio's exceptional contributions to democratic consolidation in Africa, further affirming Sierra Leone's pivotal force in African governance and development agenda.
